

Instructions bracket mounting

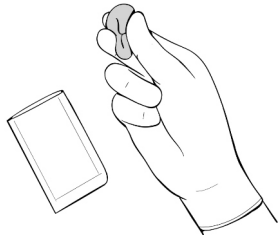
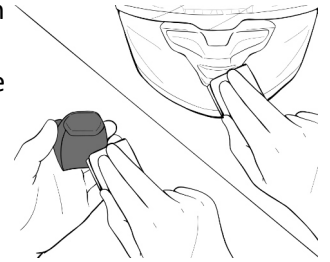


1. before mounting should check the fit on the helmet and to the Quickclip. If something is not right, this is the last moment to check everything.



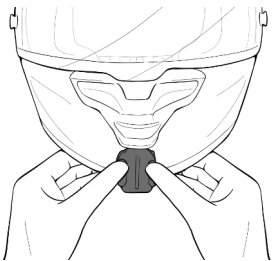
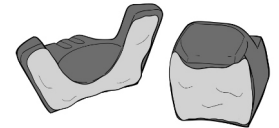
Wash hands or use disposable gloves (powder free).

3. Clean the adhesive surfaces on the holder and helmet. We recommend isopropanol or brake cleaner for this purpose. The surfaces should be dust-free, grease-free and dry before using the adhesive.



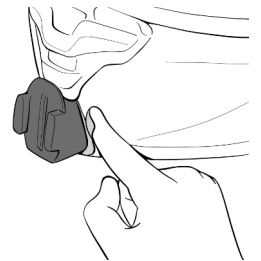
4. Open the adhesive and activate by kneading. The adhesive stains a little, but this can be easily removed with a piece of kitchen roll and/or hand washing paste.

5. Apply adhesive to the adhesive surface on the bracket. Only where the bracket touches the helmet.



6. Press the holder evenly against the helmet with light pressure and align the holder. The adhesive should be processed within 30 minutes.

7. Glue protruding from the edges can be removed with a popsicle stick, a toothpick, a piece of kitchen roll or by hand.

8. The adhesive should cure for at least 48 hours. We recommend storing on a helmet cushion so that the chin part is facing up.

The adhesive cures ~24 hrs 3 mm / ~48 hrs 5.5 mm / ~72 hrs 8 mm at 21°C.
Best processed at room temperature (21°C).
