

Assembly instructions

MiBike

1. Use the product photos at www.mibike.de or in our [eBay shop](#) to find the exact position of the mount on the helmet. Before installation, check the fit on the helmet and on the Quickclip (dry fit). If anything does not fit, now is the last chance to check it.

IMPORTANT: Mounts that have come into contact with adhesive are excluded from return or exchange.

2. Wash your hands or use powder-free disposable gloves. The adhesive is best applied at room temperature (approx. 21 °C). Note: the adhesive can only be processed properly for about 30 minutes.

3. Thoroughly clean the adhesive surfaces on the helmet and on the mount (e.g. with isopropanol or brake cleaner). Before application, the surfaces must be completely dry and free of dust and grease.




4. Open the adhesive and activate it by kneading it. The adhesive may stain slightly; this can usually be removed easily with kitchen paper and/or hand-cleaning paste.

5. Apply the adhesive to the mount's bonding surfaces - only in the areas where the mount touches the helmet. Apply a little more adhesive in the middle of these areas and a thinner layer towards the edges.



6. Position the mount, press it onto the helmet with light, even pressure and align it. The adhesive should spread right to the edges and protrude slightly on all sides of the contact area.

7. Remove any excess adhesive immediately (e.g. with a wooden spatula, toothpick, kitchen paper or by hand). Note: the adhesive can only be processed properly for about 30 minutes.

8. Allow the adhesive to cure for at least 48 hours. We recommend a curing time of 72 hours and storing the helmet on a helmet cushion with the chin section facing upwards.
